## Tús eligibility conditions

### What criteria will apply to get a placement?

- A customer :
  - o must be fully unemployed and in receipt of a jobseeker's payment continously for at least 12 months (A break of up to 30 days in the past 12 months may be permitted) and
  - o must be currently in receipt of a Jobseekers Allowance payment from the Department of Employment Affairs and Social Protection or
  - o must be in receipt of a Jobseekers Transition payment (former One-Parent Family payment OFP). No qualifying period applies.
  - o A refugee aged 18 years old, authenticated by the Department of Justice & Law Reform (Garda Registrar Certificate with Stamp 4) and getting Jobseekers Allowance payment (no qualifying period applies)

#### How much will the participants be paid?

- The rate of payment will be calculated at the maximum rate of underlying Social Welfare payment being received by the
  participant plus a top up of €22.50 per week.
- The rates of payment are as follows:

Personal Rate of Jobseekers Allowances	Max rate of €198.00 per week		
Increase for a Qualified Adult	Max rate of €131.40 per week		
Full rate child increase	€31.80		
Half-rate child increase	€15.90		

• An 'A' PRSI contribution will be paid in respect of all participants.

#### How many hours will participants be required to work?

- o Participants will work 19½ per week for a maximum duration of 12 months.
- o Two persons may share a single full-time position if required and acceptable to the community organisation.
- Work placement can spread over a full day and include weekend working arrangements.
- o There may be some degrees of flexibility in terms of the schedule of hours.

### How long can you remain on Tús?

Participation is limited to a maximum of one year from beginning of employment.

#### Who will administer Tús?

- Implementing Bodies/Local Development Companies (LEADER/Partnership companies) and Údarás na Gaeltacht will have local responsibility for delivering the work opportunities.
  - Community and voluntary organisations will be canvassed by the relevant Implementing Body/Local Development Company to provide quality work opportunities in the delivery of services.
